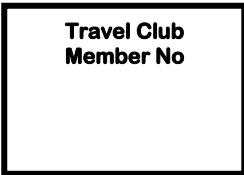

PENSHURST RSL TRAVEL CLUB BOOKING CONDITIONS

- 1. No booking will be accepted or confirmed until a deposit has been paid.
2. The paying of a deposit does not mean a booking on a tour unless you are told that seats are available and your booking is confirmed.
3. Making an enquiry to the Executive regarding a tour does not mean a confirmed booking.
4. Once a deposit has been paid and/or booking space allocated, there will be no refund unless the seat can be allocated to another member.
5. Final payment is due on the date printed on the Payment Sheet.
6. Any complaints/requests are to be made to the Travel Club representative on the coach.
7. The tour departure time is printed on the Payment Sheet and members are requested to adhere to this, as well as any coach departure times given while on tour.
8. The Executive and/or Coach Company/Captain have the right to alter any tour itinerary, subject to the prevailing conditions whilst on tour.
9. Should you be a single passenger, you will be required to pay the single supplement, unless you or the Travel Club can arrange a twin share.
10. The Executive Committee has the right to refuse any person or person's admission to any function, trip or outing.
11. Any person wishing to rejoin who has membership cancelled or refused by the Penshurst RSL Travel Club Inc. must have his/her application presented to a full monthly meeting of the Penshurst RSL Travel Club Inc. for a decision.
12. The Penshurst RSL Travel Club Inc. and/or the Executive are not responsible for members/guests whilst attending any trip/function organised by the Penshurst RSL Travel Club Inc.
